



# How to Pay Your License Fee

If you are paying the license fee at the same time you e-sign your license agreement:

1. Login to your account on our website by entering in the username and password provided into the Member Login section on the website's home page:



2. After logging in, you will be directed to the "My Account" page. Click the RLU number under the My Reservations column to view details about the license that has been assigned to your account:



- After reviewing the details about the license that has been assigned to your account, click the green “Accept Reservation” button. You will then have the opportunity to e-sign your license agreement and pay your license fee.




